Units repaired or replaced under warranty will bear the remainder of the original equipment warranty. CYBER-TECH INC. is not responsible for product damage or failure resulting from, in whole or in part, improper installation, accident, misuse, abuse, acts of God, BUYER reassembly or modifications, lack of normal and expected preventative maintenance as specified.
